RE: Santa Barbara Cruise Ship Program

Dear Santa Barbara Harbor Commissioners:

The Santa Barbara South Coast Chamber of Commerce, representing businesses from Goleta to Carpinteria, would like to express our support for cruise ship visitation and the cruise ship program. One primary focus of the Chamber is the continued economic development and success of our regions, and to make the South Coast a place where our local businesses and community members can thrive. Santa Barbara's cruise ship program has been and continues to be an important part of that success. We would like to stress that the direct economic impact of cruise ships to Santa Barbara has been supported by various studies, which have shown \$4 million in economic benefits to the city annually.

We ask that you do not establish an annual limit on cruise ships. Establishing a limit feels like an arbitrary restraint, as it does not account for the varying sizes of cruise ships and passenger counts. Not only would this create uncertainty around cruise ship revenue for the City, but it would also create uncertainty for many businesses who have come to rely on cruise ship visits. These local businesses, especially on the waterfront, plan their staffing according to cruise ship visits, with steady cruise ship visitation. A limit on cruise ships could mean the difference between part-time and full-time employment for the various employees at these local businesses. Additionally, an annual limit would create issues regarding the cruise line itineraries, impacting scheduling, potentially leading to an even greater loss of cruise ship visitation.

As a key partner to local businesses, the Waterfront, and cruise lines, the Chamber continues to increase awareness of, and accessibility to, the economic benefits of cruise ship visitation. We do so through our Visitor Center Manager, our Visitor Center staff, our volunteers, our Visitor Center Advertising Manager, and our Tourism and Communications Manager. The Chamber is in close contact with our members, which we promote to cruise ship visitors, guaranteeing that the goods and services we highlight to visitors are relevant and available. Both businesses and visitors consistently give positive feedback regarding cruise ship visitation. The positive feedback from cruise ship visitors on their experience in Santa Barbara is often exceptional, leading to return visits and invaluable word of mouth to bring future visitation to the City which will in turn support additional businesses, as well as an increase in TOT.
